

## The Essentials

### *How to Book*

To secure your guaranteed entry into one of the Adventure Time Travel packages return your completed Registration of Interest form and pay the non-refundable \$500 initial deposit.

Bank details are as follows for electronic transfers or direct deposits at an ANZ bank branch. Please use your surname and event in the transaction description for easy reference.

A receipt will be emailed to you on receipt of your deposit.

Credit card payment is available upon request. These transactions will incur a fee.

Please note the Cancellation clause below regarding any deposit or payments made to Adventure Time Travel. In addition, it is recommended that travel insurance be arranged immediately after making the booking (refer to the Travel Insurance clause below).

### *Travel Package*

Entry to events is available only by way of purchasing a travel package. Entry only is not available and must be purchased in conjunction with an Adventure Time Travel package.

### *Final Itinerary*

An Information Pack will be issued approximately 3 weeks prior to your departure.

### *USA Travel Requirements*

Travellers to the USA require an ETSA Visa, which can be applied for online via the official site <https://esta.cbp.dhs.gov/>.

Australian passport holders passport must be valid for a period of at least of six months, calculated from the date of your return to Australia. Other country's passport holders must check USA requirements regarding passport validity dates.

All travellers are responsible to ensure that all their travel documents are current and valid.

## Terms & Conditions

### *Fees & Amendments*

A \$55 late payment fee is applicable for any payment received after its due date. If any payment is not received within 5 working days of the due date, you will be deemed to have cancelled your booking.

A \$110 late booking fee may apply for reservations made within two months from the date of travel package commencement.

An amendment/change to a confirmed booking will incur a fee of \$55 per person per change, plus any fees levied by other suppliers. If the amendment/change is made within one month of the date of travel package commencement a \$110 fee will apply per person per change (plus any fees levied by other suppliers).

### *Prices*

Prices are quoted in AUD at today's rate and are subject to changes due to currency fluctuations or changes by service providers until paid in full.

### *Entrants Transfer*

Race entries are strictly non-transferrable by NYRR.

### *Travel Insurance*

Adventure Time Travel do not include personal travel insurance in the package price.

Adventure Time Travel require that you have travel insurance and it is a condition of booking that you provide a copy of your travel insurance policy confirmation to us. It is your responsibility to ensure that you are adequately insured for the full duration of your trip in respect of illness, injury, death, loss of baggage and personal items and cancellation/interruption and curtailment, as well as all of the activities you expect to participate in.

### *Airfares and Airport/Security Taxes*

We strongly recommend your airfares be booked through Adventure Time Travel partners to ensure all your travel arrangements coincide and your trip runs as smoothly as possible. Please note that Airport and Security Taxes are charged when paying for airfares but there may be additional taxes at some international/domestic airports upon departure.

### *Cancellations*

Once lodged, all payments are non-refundable and non-transferrable. This condition applies to all circumstances, including to, but not limited to, the cancellation of the event, or to your cancellation.

It is recommended that travel insurance be arranged immediately after making the booking (refer to the Travel Insurance clause below).

### *Event Cancellation*

In the event that a race is cancelled for any reason the cancellation clause will apply including race entry fees, subject to Adventure Time Travel being refunded by race organisers.

### *Force Majeure*

If Adventure Time Travel is prevented (directly or indirectly) from performing any of its obligations under this agreement by reason of act of God, strikes, trade disputes, fire, breakdowns, interruption of transport, government or political action, acts of war or terrorism, acts of omissions of a third party or for any other cause whatsoever outside Adventure Time Travels reasonable control, Adventure Time Travel will be under no liability whatsoever to you and may, at its option, by written notice to you to cancel the tour.

### *Release and Waiver of Liability*

In consideration of Adventure Time Travel accepting your application:

- You release Adventure Time Travel and its officers, employees, agents and other representatives and recommended charity beneficiaries (hereafter "Adventure Time Travel and its personnel") from all cost, liability, loss or damage incurred or suffered by you directly or indirectly during the course of your travel and resulting from your personal injury, illness or death or damage to or loss of your property unless caused by the wilful negligence or wrongful act of Adventure Time Travel and its personnel; and
- You waive any claims you have, or may at any time have, against Adventure Time Travel and its personnel and you agree, by accepting the inherent dangers and risks associated with any travel, not to make any claim against or seek any compensation from Adventure Time Travel and its personnel in respect of any personal injury, illness or death suffered by you or damage to or loss of property sustained by you as a result of your participation in an event.

To the extent permitted by law, section 74 of the Trade Practices Act 1974 does not apply to this agreement.

### *Disclaimer*

Adventure Time Travel reserves the right to refuse an application to register for any reason. Should an entrant's application be refused, the full registration fee (including the non-refundable initial deposit) will be refunded to the applicant. Your registration for an event takes effect once you complete the Registration of Interest form, accept the booking 'Essentials' and 'Terms and Conditions' and the initial deposit has been received in full by Adventure Time Travel. Places are limited for the events and are allocated on a first come first served basis.

## *Privacy Act*

The Customer agrees for Adventure Time Travel to obtain from a credit-reporting agency a credit report containing personal credit information about the Customer in relation to credit provided by Adventure Time Travel .

The Customer agrees that Adventure Time Travel may exchange information about Customer with those credit providers named in the Application for Credit account or named in a consumer credit report issued by a reporting agency for the following purposes:

- a) to assess an application by Customer;
- b) to notify other credit providers of a default by the Customer;
- c) to exchange information with other credit providers as to the status of this credit account, where the Customer is in default with other credit providers; and
- d) to assess the credit worthiness of Customer.

The Customer consents to Adventure Time Travel being given a consumer credit report to collect overdue payment on commercial credit (Section 18K(1)(h) Privacy Act 1988).

The Customer agrees that Personal Data provided may be used and retained by Adventure Time Travel for the following purposes and for other purposes as shall be agreed between the Customer and Agent or required by law from time to time:

- a) provision of Goods and/or Services;
- (b)marketing of Goods and/or Services by Adventure Time Travel , its agents or distributors in relation to the Goods and/or Services;
- c) analysing, verifying and/or checking the Customer's credit, payment and/or status in relation to the provision of Goods and/or Services;
- d) processing of any payment instructions, direct debit facilities and/or credit facilities requested by Customer; and
- e) enabling the daily operation of Customer's account and/or the collection of amounts outstanding in the Customer's account in relation to the Goods and/or Services.

Adventure Time Travel may give, information about the Customer to a credit reporting agency for the following purposes:

- a) to obtain a consumer credit report about the Customer; and or allow the credit reporting agency to create or maintain a credit information file containing information about the Customer.
